**GROUP PERSONAL ACCIDENT INSURANCE SUB-BRANCH
AND WOMEN'S AUXILIARY MEMBERS**

As you would be aware, this State Branch through negotiation with our Insurance Broker, Scott and Broad introduced a scheme in August 1979 to provide RSL sub-Branch members with accident insurance. The policy was later extended to cover Women's Auxiliary members.

This year, you will be covered for twelve (12) months, from 31st May, 2016 to 31st May, 2017. Also the premium is still **66 cents per member (Inc GST)**. We also confirm that "Accident Coverage To and From RSL sub-Branch/Women's Auxiliary Meetings" is included.

Please Remember: If your sub-Branch has a Chapter, please include the number of members in your Chapter in your sub-Branch membership total.

Please note that Scott & Broad have been able to negotiate increased cover with Accident and Health as follows:-

- Weekly Benefits (Income Earners) increased from \$220 per week to \$750 maximum per week
- Home Help increased from \$220 per week to \$500 maximum per week
- Non-Medicare Medical expenses increased from \$1,000 to \$2,000 maximum

- May - Scott & Broad renew insurance coverage.


