



Exemption under the *Public Health (COVID-19 Restrictions on Gathering and Movement) Order 2021* under the *Public Health Act 2010 (NSW)*

I, Brad Hazzard, Minister for Health and Medical Research, under clause 43 of the *Public Health (COVID-19 Restrictions on Gathering and Movement) Order 2021* (the Order) hereby exempt a person from clause 35 of that Order for the following events, subject to the conditions set out below:

1. The exemption applies to the ANZAC Day march organised by the Returned and Services League of Australia (New South Wales Branch) ('RSL NSW') and held in the Sydney Central Business District on 25 April 2021.
2. RSL NSW must ensure the number of participants must not exceed one person per 2 square metres of space to a maximum of 5,000 persons.
3. RSL NSW must develop and comply with a COVID-19 Safety Plan that has been submitted to NSW Health for review.
4. Each person participating in the march must provide their name, telephone number or email address to RSL NSW and take reasonably practicable steps to comply with the COVID-19 Safety Plan developed by RSL NSW.

Note: A separate exemption applies to any other outdoor ANZAC Day march or service held in Greater Sydney between 18 and 25 April 2021.

The exemption is repealed on 26 April 2021.

Exemption under the *Public Health (COVID-19 Restrictions on Gathering and Movement) Order 2021* under the *Public Health Act 2010 (NSW)*

I, Brad Hazzard, Minister for Health and Medical Research, under clause 43 of the *Public Health (COVID-19 Restrictions on Gathering and Movement) Order 2021* (the Order) hereby exempt a person from clause 35 of that Order subject to the conditions set out below:

1. The exemption applies to any outdoor ANZAC Day march or service held in Greater Sydney between 18 and 25 April 2021.
2. There must be a nominated organiser for each outdoor ANZAC Day march or service.
3. An outdoor ANZAC Day march or service held in Greater Sydney must not exceed one person per 2 square metres of space to a maximum of 3,000 persons.
4. The nominated organiser of an outdoor ANZAC Day march or service must develop and comply with a COVID-19 Safety Plan required for outdoor protests.
5. Each person participating in an outdoor ANZAC Day march or service must provide their name, telephone number or email address to the nominated organiser and take reasonably practicable steps to comply with the COVID-19 Safety Plan developed by the nominated organiser.

Note: The ANZAC Day march organised by the Returned and Services League of Australia (New South Wales Branch) ('RSL NSW') and held in the Sydney Central Business District on 25 April 2021 is the subject of a separate exemption.

The exemption is repealed on 26 April 2021.

Exemption under the *Public Health (COVID-19 Restrictions on Gathering and Movement) Order 2021* under the *Public Health Act 2010 (NSW)*

I, Brad Hazzard, Minister for Health and Medical Research, under clause 43 of the *Public Health (COVID-19 Restrictions on Gathering and Movement) Order 2021* (the Order) hereby exempt a person from clause 35 of that Order subject to the conditions set out below —

1. The exemption applies to any outdoor ANZAC Day march or service held outside Greater Sydney between 18 and 25 April 2021.
2. There must be a nominated organiser for each outdoor ANZAC Day march or service.
3. An outdoor ANZAC Day march or service held in a region outside Greater Sydney must not exceed one person per 2 square metres of space to a maximum of 3,000 persons.
4. The nominated organiser of an outdoor ANZAC Day march or service must develop and comply with a COVID-19 Safety Plan required for outdoor protests.
5. Each person participating in an outdoor ANZAC Day march or service must provide their name, telephone number or email address to the nominated organiser and take reasonably practicable steps to comply with the COVID-19 Safety Plan developed by the nominated organiser.

The exemption is repealed on 26 April 2021
