RSL NSW - 2023 ELECTION OF THE BOARD OF RSL NSW BY ALL SERVICE MEMBERS

In accordance with the agreed instructions, we have received and summarised the votes for the 2023 Election of the Board of RSL NSW by all Service Members.

In respect of each vote received online and by post up to 12:00pm (AEDT) on Monday, 09 October 2023, we conducted the following work:

- A. Checked that the RSL NSW member appeared on the register of entitled members as supplied by RSL NSW;
- B. Checked whether voting instructions were validly completed and invalidated any votes based on processing instructions as agreed with RSL NSW;
- C. Ensured that each member only voted once and if two votes or more were received, their final voting instruction was accepted;
- D. Monitored votes received to assure probity and election integrity.

The final results are summarised on the following page.

A total of 1,544 valid votes were received on the President Ballot, with no invalid votes received. 49 of these were postal votes.

A total of 1,566 valid votes were received on the Director Ballot, with no invalid votes received. 48 of these were postal votes.
